- History booths provide educative materials for guests to let them learn about European history and culture.

TERMS

1. **Audition:** Artists who have not performed at previous Colorado European Festivals may be required to audition for the Colorado European Festival (CEF) Festival Committee.
2. **Performance Duration:** Unless otherwise specified in writing by the CEF, each performance will be a minimum of 20 minutes and a maximum of 30 minutes in length.
3. **Payment:**
 - a. Payments for performances (if any will be negotiated on an individual basis with the CEF.
 - b. Performers will be paid honorarium or reimbursement on the day of the event.
4. **Performance Promotion:**
 - a. Performers will be featured in the Festival program book and on the festival website.
 - b. Performers may be feted in press releases to be sent to major Denver area publications prior to the event.
